CONSTITUTION OF THE IMOCUNIGO

WE THE REPRESENTATIVES OF THE IMOCUNIGO DETERMINED

To Preserve and Protect the Idealism of Humanity and Reaffirm our Faith, in Fundamental Human Rights, Social Justice, Humanitarian Affairs, Public Safety Services, and the Right of the Citizenship to Life Sustaining Resources, ergo, Food, Water, Health Care and Housing Services. Furthermore, we establish conditions under-which respect for the Rule of International Law and Fundamental Freedoms, fosters a platform of Change and Action, by engaging the Member States, Civil Society and Other Non-State Actors on an equal playing field. Therefore, ensuring the Citizenship Right to Life and the Promise of Tomorrow.

Moreover, giving the International Mission Of OCUNIGO a true and everlasting ability to serve the Greatness of Humanity. Further, ensuring, the Citizen's Right to Fair and Equal Access to Unconditional Resources, in the realm of Food, Water, Health Care, Housing and Educational Services, at no cost. In addition, Foster Positive Respect for Equality and Social Justice, for all-regardless of a Citizen Race, Sexuality, Disability and/or Nationality. We duly believe, in the Promise of Tomorrow and will take paramount steps, to deliver our commitment towards, Humanity and the Security of Oneself.

AND FOR THESE ENDS

To Practice Tolerance and Live Together in Peace with one another as Good Neighbors, and

To unite our strength to maintain International Peace and Humanitarian Affairs Services.

To ensure, by the acceptance of Principles and the Institution of Methods, that No Military Force be used, and

To Employ International Machinery for the Promotion of the Economic and Social advancement of all Peoples, regardless of Race, Sexuality, Disability and/or Nationality.

HAVE RESOLVED TO COMBINE OUR EFFORTS TO ACCOMPLISH THESE AIMS.

Accordingly, our respective Organizations, through Representatives Assembled in the City of New York, who have exhibited their full powers and founded to be within good and due form, have agreed to the present Constitution of the International Mission of OCUNIGO and do hereby establish an International Organization, to be known as the "International Mission of OCUNIGO".

Section I

PURPOSES AND PRINCIPLES

Article 1

The Purposes of the International Mission Of OCUNIGO:

- To Develop Friendly Relations amongst Member States based on Respect for the Rule of Law, Human Rights, Social Justice, and the Self-Determination of Peoples. To take any Appropriate Measures to Strengthen Universal Peace and the Goals of Humanity,
- To achieve International Cooperation, in solving International Problems of an Economic, Social
 Justice and/or Humanitarian Character. Promoting and Encouraging Respect for Human Rights
 and Fundamental Freedoms for all without distinction as to Race, Sexuality, Disability and/or
 Nationality.
- 3. To be a Complete Center for Harmonizing the Actions of Member States, Civil Society Organizations, Private Non-State Actors, in the fulfillment of these common ends.

Article 2

The International Mission Of OCUNIGO and Members, in pursuit of the Purposes stated in Article-I, shall act in accordance with the following Principles.

- 1. The Organization is based on the principle of the Sovereign Equality of all its Members, Principal Leadership and Employees.
- 2. All Members States, to ensure all of them the Rights and Benefits resulting from Membership, shall implement in good faith the obligations assumed by them, in accordance with the Present Constitution of the International Mission Of OCUNIGO.
- 3. All Member States shall settle, International Disputes by Peaceful Means. In a manner that enshrines International Peace, Security and Justice, and further ensure, these Principles are not Endangered.
- 4. All Members States shall refrain, from any relations to the threat and/or use of force against the Territorial Integrity or Political Independence of any Nation, not consistent with the Purposes of The International Mission Of OCUNIGO.
- 5. All Member States shall provide "The International Mission Of OCUNIGO" assistance on any action, deemed essential in accordance, with the Present Constitution. The Member States shall Refrain from Providing Assistance to any Nation, NGO, IGO and/or Private Sector Organizations against, which the International Mission Of OCUNIGO is taking Preventive or Enforcement Action.
- The International Mission Of OCUNIGO shall ensure that Any-Nation, not Members Act in Accordance with these Principles. As may be Necessary for the Maintenance of International Peace and Security of Oneself.

MEMBERSHIP

Article 3

The original Members States of the International Mission Of OCUNIGO shall be the Nations. Which, having Participated in the Conference on International Intergovernmental Organizations New York and/or previously signed the Present Constitution in Accordance with Article-1.

Article 4.

- 1. Membership within "The International Mission Of OCUNIGO" is duly opened, to all Peace-Loving Nations. Which Recognizes the obligations contained in the present Constitution.
- 2. Furthermore, in the judgment of the International Mission Of OCUNIGO, able and willing to carry out these Obligations, in the Furtherance of Humanity.
- The Admission of any Member States, NGO, IGO and/or Private Sector Organization, to the International Mission Of OCUNIGO will be prompted by a decision of the Advisory Committee and Chairperson.

Article 5

A Member of the International Mission Of OCUNIGO, which has Persistently Violated the Principles contained in the Present Constitution may be Expelled from the Organization, by the Head Of Delegation, upon the Recommendation of the Advisory Committee and Chairperson.

Section 3

ORGANS

Article 6

Established as the Principal Organs of the International Mission Of OCUNIGO: an Executive Offices of the Head Of Delegation, an Executive Offices of the Deputy Head of Delegation, an Director Of Finance, an Representative of Public Information, an Representative for Public Safety, an Representative for Disability Services, an Political Affairs Advisor, an Representative for South Asia Affairs, an Representative for Foreign Affairs, an Representative for African Affairs, an Representative for Disarmament Affairs, an Advisory Committee & Chairperson and Headquarters within New York USA, London United Kingdom and Other Global Locations. As Recommended by the Advisory Committee Chairperson.

Article 7

- 1. Subsidiary Organs may be Formed & Established, under the Present Constitution.
- The International Mission Of OCUNIGO shall Place No Restrictions on the Eligibility of Men and Women to Participate in Any Capacity and under the Condition of Equality, within Principal and Subsidiary Organs of the International Mission Of OCUNIGO.

FUNCTIONS AND POWER

Article 8

The International Mission Of OCUNIGO and Subsidiary Organs, May Discuss and/or Question Any Matter within the confines of the Present Constitution. Relating to the Powers and Functions of any Subsidiary Organ (s) provided, in the Present Constitution. The International Mission Of OCUNIGO & it's Subsidiary Organs shall Present Recommendations to the Member States, the Security Council, the Human Rights Council on any Questions or Matters, thereof.

- 1. The International Mission Of OCUNIGO and Head Of Delegation May Call to the Attention Of Member States & the Human Rights Council Any Situation (s), which likely to Endanger International Peace and Security Of Oneself.
- 2. The Powers of the International Mission Of OCUNIGO are hereby set-forth within the present Article shall not limit the general scope of Article-2

Article 9

The International Mission Of OCUNIGO shall Initiate Studies & Make Recommendations for the Purposes Of:

- 1. Promoting International Cooperation within the Characteristics of Humanitarian, Social Justice, Human Rights, Public Safety, Education, Health Care, Disciplines.
- 2. Encourage Progressive Development of International Law and Codification.
- 3. Assistintherealization of Human Rights and Fundamental Freedoms for Allwithout any Distinction, to Race, Sexuality, Language, Disability, Religion and/or Nationality.

Article 10

Subject to the Provisions of Article-2, The International Mission Of OCUNIGO May Recommend Measures for the Peaceful Adjustment of any Situation, regardless of origin. Which considers to Impair the General Welfare and/or Friendly Relationships amongst Member States. As set-forth within the Purposes and Principles of the International Mission Of OCUNIGO.

- The International Mission Of OCUNIGO shall Receive and Consider Annual and/or Specialized Reports from the Permanent Representatives; these reports shall include: An Accounting of the Measures they have taken to Maintain International Peace and Security Of Oneself.
- 2. The International Mission Of OCUNIGO shall Receive and Consider Reports from any Unrelated-Organization of the International Community, Reflective of their Authority.
- 3. The Advisory Committee shall Consider and Approve the Annual Budget of the International Mission Of OCUNIGO and its Subsidiary Organs. In Consultation with the Head Of Delegation, Director of Finance and Member States.
- 4. The Expenses of the International Intergovernmental Organization shall be Funded by the Member States Allocations, as Approved by the Advisory Committee.

- 5. The Advisory Committee Shall Consider and Approve All Financial and Budgetary Arrangements with Specialized Agencies: as referred under Article-10 section-2 and shall examine the Administrative Budgets of Specialized Agencies with a viewpoint of making formal recommendations.
- 6. The Advisory Committee Shall Meet (2) Regular Annual Sessions and/or in Special Sessions as Required. The Special Sessions Shall and/or May Be Invoked by the Head Of Delegation.
- 7. The Advisory Committee Shall Adopt its Own Rules Of Procedure. The Chairperson Shall be Elected for each Session of the Advisory Committee.

REGIONAL ARRANGEMENTS

Article 11

Nothing in the Present Constitution, Precludes the Existence of Regional Arrangements and/or the Agencies from Dealing with Matters Relating to the Maintenance of International Peace and Security of Oneself. As appropriate for Regional Action, provided that arrangements or their activities are consistent with the Purposes and Principles of the International Mission Of OCUNIGO.

- 1. The Member States of the International Mission Of OCUNIGO entering into such arrangements or instituting such agencies shall make every effort to achieve peaceful settlement of local disputes through Regional Arrangements, before referring to the Head Of Delegation.
- 2. The Advisory Committee Shall Encourage the Development of Settlement Regimes, regarding Local Disputes.
- 3. The International Mission Of OCUNIGO and its Subsidiaries, Shall be kept fully informed of Activities undertaken and/or In Contemplation, under the Regional Arrangement Regimes.

Section 6

INTERNATIONAL ECONOMIC AND SOCIAL COOPERATION

Article 12

Having a genuine view towards, Creation of Conditions Of Stability and Well-being, which are duly Necessary for Peaceful and Friendly Relations amongst the Member States, based on Respect for the Principle of Equal Rights and Self-Determination of Peoples. The International Mission of OCUNIGO Shall Promote:

- Higher Standards Of Living, Full Employment and Conditions of Economic and Social Progress and Development.
- 2. Universal Respect and Observance of Human Rights and Fundamental Freedoms for All, without Distinction, to Race, Sexuality, Language, Disability, Religion and/or Nationality.
- 3. All Members Pledge "Themselves" to take Joint and Separate Action in Cooperation with the International

Mission Of OCUNIGO for the achievement of the Purposes set forth in Article-1 Section-2.

Section 7

MISSION OF OCUNIGO

Article 13

The Mission Of OCUNIGO Shall Comprise of a Head Of Delegation & Commissioner, and Other Supportive Staffing, as The International Mission Of OCUNIGO may require. The Head Of Delegation Shall be Appointed by the Member States. Under the Recommendations of the Advisory Committee Chairperson. The Head Of Delegation Shall be the 'Chief Administrative Officer' of The International Mission Of OCUNIGO.

Article 14

The Head Of Delegation & Commissioner Shall Act within that capacity, During All Meetings of The International Mission Of OCUNIGO, the Advisory Committee, the Subsidiary Organs and/or under Attendance to Any Meeting Conducted by Another Organization, Private Sector Business and/or Public Safety Community.

Article 15

The Head Of Delegation & Commissioner Shall Perform, Any other Function, as are Entrusted by the Member States. The Head Of Delegation & Commissioner Shall Present An Annual Report to the Member States of the United Nations on the work of The International Mission Of OCUNIGO.

Article 16

The Head Of Delegation & Commissioner May Bring to the Attention of the Member States, Human Rights Council and/or Security Council. Any Matter, which in "Their" Official Opinion, May Threaten the Maintenance of International Peace and Security Of Oneself.

Article 17

- 1. The Supportive Staffing shall be Appointed by the Head Of Delegation & Commissioner, under the Strict Regulations Established by the Advisory Committee & Chairperson.
- 2. Appropriate Staffing shall be Permanently Assigned to the Executive Offices of the Head Of Delegation, the Deputy Head of Delegation, the Director of Finance, the Permanent Representatives and As Required, Other Subsidiary Organs of the International Mission Of OCUNIGO. The Staffing shall Form Part of the International Mission Of OCUNIGO.
- 3. The Paramount Consideration, for the Employment of the Staff and the determination of the Conditions Of Service, shall be the Necessity Of Securing the Highest Standards of Efficiency, Competence, and Integrity. Due Regard shall be Paired to the Importance Of Recruiting Staff on an Geographical Basis, as possible.

MISCELLANEOUS PROVISIONS

Article 18

All International Agreements Entered, by a Representing Member of The International Mission Of OCUNIGO, after the Present Constitution enters into force. Shall as soon as possible be registered with The International Mission Of OCUNIGO and published.

1. No Party to Any International Agreement, which has not been registered, in accordance with the Provisions of Paragraph-1 of this Article. May invoke "that" Agreement, before Any Subsidiary Organ of The International Mission Of OCUNIGO.

Article 19

In the event of a Conflict Between the Obligations of the Members States, of The International Mission Of OCUNIGO, under the Present Constitution, and "Their" Obligations under any other International Agreement. Their Obligations under the Present Constitution Shall Prevail.

Article 20

The International Mission Of OCUNIGO shall enjoy in the Territory of its Member States, All Legal Capacity, as may be Necessary for the Exercise of its Functions and Fulfillment of its Purposes.

Article 21

The International Mission Of OCUNIGO shall enjoy in the Territory, of Member States All Privileges and Immunities, as are Necessary for the Fulfillment of its Constitutional Purposes.

- 1. Representatives of the International Mission Of OCUNIGO and Officials shall similarly enjoy All Privileges and Immunities, as are Necessary for the Independent Exercise of "Their" Functions in Connection with The International Mission Of OCUNIGO.
- 2. The Advisory Committee Chairperson May create Recommendations with a view to Determining the Details of the Application of Paragraphs 1 and 2 of this Article or May Propose Convention (s) to the Member States of the International Mission Of OCUNIGO & UN.

Section 9

AMENDMENTS

Article 22

Amendments to the Present Constitution shall come into force for all Member States and Executive Officers of the International Mission Of OCUNIGO when they have been Formally Adopted.

Article 23

A General Conference of the Members States of the International Mission Of OCUNIGO for the Purposes of Reviewing, the Present Constitution may be held at a Date and Place to be Determined by a Two-Thirds Vote of the Advisory Committee.

AUTHORIZATION AND SIGNATURE

Article 24

The present Constitution shall be authorized by the Signatory Member States in accordance with their respective Constitutional Processes:

 The ratifications shall be deposited with the Governments of the Member States to the United Nations. Which shall notify the Head Of Delegation, when the Member States Constitutional Processes been conducted.
